Risk assessment is relating to:

- The assessment was carried out in accordance with the principles of Good Laboratory Practice and Good Manufacturing Practice (GLP, GMP): conditions of production and storage without harm to the health of the consumer under normal and foreseeable use, and in compliance with the cautionary notes and instructions for use.

The chemical characteristic, toxicological parameter and the level of raw material used in the final product were considered.

Cosmetic product does not contain ingredients classified as carcinogenic, mutagenic and toxic by reproduction (CMR) and classified as categories 1A, 1B and 2 according to EU Regulation No 1272/2008.

Cosmetic product does not contain ingredients derived from genetically modified plants or products

of animal origin.

Cosmetic product was not tested on animals.

According to the available information on the effects of the product and its ingredients, they are considered harmless for health. Products are considered SAFE when used under normal and reasonably foreseeable conditions of use.

Except for users with strong allergic reactions, that rarely may cause undesirable effects.
